**3. MOTIONS**

**a. Motions without Notice**

1. Hon. Baloyi on behalf of the ANC moved without notice; that the House:

- i. Urges Government to intervene in the supply of electricity to the Matlosana Local Municipality.

- ii. noted that the Municipality owes Eskom R134 million of which R34 million is owed by the Government Departments.
- iii. Further noted that Eskom intends to cut the power supply to the Municipality on the 14<sup>th</sup> March 2013.

The House adopted the above motion.

2. Hon. Hattingh on behalf of the DA moved without notice; that the House:

- i. Notes a concern on the latest reports of the allegations of a plot to assassinate one Member of the House.
- ii. Further emphasized that those who are allegedly implicated should be brought to book.

3. Hon. Motshegare on behalf of the UCDP moved without notice: that the House:

- i. Notes and highlights a sickening condition which our country is experiencing in relation to rape and murder.
- ii. Notes that such acts could be described as inhumane and demonic.
- iii. Conveys condolences to the Sefularo's and Ramanyini's family.

The House adopted the abovementioned motion.

4. Hon. Mahlakeng on behalf of the ANC moved without notice: that the House:

- i. Congratulates the South African Police Service and other law enforcement agencies for breakthrough that they have made in apprehending alleged suspects in the murder case of Mr. David Obuti Chika.
- ii. Further calls for calm in order to allow the judicial process to run its course without hindrance.
