


**NORTH WEST YOUTH COMMISSION AMENDMENT
ACT NO. 3 OF 2003**

[ASSENTED TO 28/08/2003]

[DATE OF COMMENCEMENT TO BE PROCLAIMED]


(English text signed by the Premier)

Act

To amend the North West Youth Commission Act, Act No.14 of 1994 as amended by Act No. 3 of 1999: in section 3 so as to provide for a term of office of the Youth Commissioners that will correspond with the term of office of the provincial legislature; in Section 3A to provide for the conditions of service of the Youth Commissioners; in section 4A to provide for the procedure of the meetings of the Commission and for incidental matters.

Be it enacted by the Legislature of the North West Province as follows:

1. Amendment of Sections 3(4) and 3(5) of Act 14 of 1994 as amended by Act No. 3 of 1999.

3. Sub-sections (4) and (5) of Section 3 are substituted as follows:

(4) Subject to the provisions of subsection (3), a term of office for the Commission shall correspond with the term of office of the

provincial legislature stipulated in section 108 (1) of the Constitution: Provided that the Premier may remove any member of the Commission from office before expiration of the said term of office, if in his or her opinion there are sound reasons for doing so; and Provided further that any member of the Commission may be re-appointed for a further term of office.

(5) Notwithstanding the provisions of sub-section (4), a member of the Commission may resign from office by submitting at least one month's written notice to the Premier.

2. Amendment of Sections 3(8) of Act 14 of 1994 as amended by Act No. 3 of 1999.

Section 3 (8) of Act 14 of 1994 as amended by Act No. 3 of 1999 is hereby deleted.

3. Insertion of section 3A of Act 14 of 1994 as amended by Act No. 3 of 1999

3A. Conditions of Service of the Youth Commissioners

The members of the Youth Commission shall be appointed on such terms and conditions, and shall receive such remuneration, allowances and other service benefits, as the Premier may determine in consultation with the Executive Council of the Province.

4. Amendment of Section 4 (h) of Act 14 of 1994 as amended by Act No. 3 of 1999

Paragraph (h) of Section 4 of Act 14 of 1994 as amended by Act No. 3 of 1999 is hereby amended as follows:

- (h) "on a quarterly basis report to the Premier on its activities and submit a consolidated annual report to the Premier before September each year"

5. Insertion of section 4A of Act 14 of 1994 as amended by Act No. 3 of 1999

4A. Meetings of the Commission

- (1) Meetings of the Commission shall be held quarterly and at such place and time as shall be determined by the Commission: Provided however that the first meeting of the Commission which shall be presided over by the Premier shall be held on such date and at such time and place as the Premier may determine, which date shall not be later than thirty (30) days after the constitution of the Commission.
- (2) The Chairperson of the Commission shall preside over all the meetings of the Commission except for the meeting mentioned in sub-section (1).
- (3) The Chairperson shall prescribe the procedure of the meetings of the Commission.

(4) The quorum for any meeting of the Commission shall be fifty percent plus one (50% + 1) of the number of serving members: Provided that for any resolution or decision to be taken a simple majority (fifty percent plus one) of members present shall suffice.

6. Short title

This Act shall be called the North West Youth Commission Amendment Act No. 3 of 2003 and shall come into operation on a date fixed by the Premier in the Government Gazette.
