It is hereby notified that the Premier has assented to the following Act which is hereby published for general information:-

Act No.6 of 2000: Public Finance Management Act, 2000

Hierby word bekend gemaak dat die Premier sy goedkeuring geheg het aan die onderstaande Wet wat hierby ter algemene inligting gepubliseer word:-

ACT

To give effect to certain provisions of the Public Finance Management Act, 1999, in the North West Province; to provide for the repeal of the North West Provincial Exchequer Act, 1994, to give effect to sections 120(2) and 226 of the Constitution of the Republic of South Africa, Act 108 of 1996; and to provide for matters in connection therewith.(English text signed by the Premier on 17/10/2000).

BE IT ENACTED by the Legislature of the North West Province, as follows:

1. **Definitions** In this Act, unless the context otherwise indicates –

“the Act” means the Public Finance Management Act, 1999 (Act No.1 1999 as amended by 29 of 1999).
2. **Amendment of Money Bill**
 - (1) Before the approval of an appropriation act, the appropriation Bill concerned may, after introduction in the Provincial Legislature, only be amended as contemplated in section 120(2) of the Constitution, Act 108 of 1996, by means of a motion made by the Member of the Executive Council responsible for finance, which motion shall be made in Committee of the whole House of the Provincial Legislature, if necessary.
 - (2) A motion contemplated in sub-section (1) shall be dealt with in accordance with the rules and order of the Provincial Legislature as contemplated in section 116 of the Constitution Act, 1996.
3. **Direct charges against Provincial Revenue Fund**
 - (1) The following payments or withdrawals from the North West Provincial Revenue Fund are direct charges against the Provincial Revenue Fund:
 - (a) transfers in terms of section 23(3) of the Act;
 - (b) payments in terms of section 24 (1)(b) and (c) of the Act;
 - (c) investments in terms of section 24(3) (a) of the Act
 - (d) expenditure in terms of section 25(1) of the Act;
 - (e) withdrawals of funds in terms of section 29(1)of the Act;and
 - (f) any utilization of savings in terms of section 43 (1) of the Act
4. **Repeal of Act of 1994**
 - (1) The North West Provincial Exchequer Act, 1994, (Act No.4 of 1994) is hereby repealed to the extent and with effect from the dates specifies in the Schedule hereto

5. Savings

- (1) Anything concluded, performed or done in terms of a provision of the North West Exchequer Act, 1994, which can be done in terms of the Act, shall be regarded as having been done in terms of the corresponding provisions of the Act.

6. Short Title and Commencement

- (1) This Act is called the North West Finance Act, 2000, and takes effect on 1 April 2000.
